Contribution Regulation and Procedure for Publication

- 1. Basic Regulation
- Requirement for contributors.

The Resources Processing of Japan (referred as RPSJ, hereafter) welcomes contribution but at least one of the authors shall be a member of RPSJ. However, there is an exception case which the editorial board of RPSJ approves to accept the

However, there is an exception case which the editorial board of RPSJ approves to accept the manuscripts which are not written by RPSJ members.

- Double of contribution is not permitted. Manuscripts contributed to RPSJ shall neither be contributed to other journals, shall be under reviewing elsewhere, nor have been already published. Contents of the manuscript shall not overlap with those manuscripts.
- Manuscripts shall be written in English or Japanese.
- Manuscripts shall be written according to the RPSJ style instructions for manuscript.
- 2. Type of Manuscripts
- 2.1 Original Papers
 - > Original research papers with well discussed on the results.
 - Abstract shall be no more than 100 words, and 5 keywords (at least) are necessary.
 - > The length of papers shall be within 6 printed pages.
- 2.2 Reviews Papers
 - Providing an update of resource processing/material science/recycling technology and their applications.
 - Abstract shall be no more than 100 words, and 5 keywords (at least) are necessary.
 - > The length of papers shall be within 10 printed pages.

2.3 Lectures

- A type of review with the educational purpose for students and young scientists/engineers/researchers.
- Historical reviews on science, technology or industry will be included. Lectures will be published in a series.
- > The length of papers shall be within 6 printed pages.

2.4 Special Issues

- ➢ Invited talks in the regular meetings in springs and falls are published, which are approved to be published by editorial board.
- Abstract shall be no more than 100 words, and 5 keywords (at least) are necessary.
- > The length of papers shall be within 6 printed pages.

2.5 Information

- ▶ Including academic/technical contents and accelerates the research and development.
- > The length of papers shall be within 4 printed pages.

2.6 Letters

- Short manuscript which reports on a brief accomplishment including important or new results.
- Abstract shall be no more than 100 words, and 5 keywords (at least) are necessary.
- > The length of papers shall be within 3 printed pages.

2.7 Products Notes

Articles on equipments/machinery/materials relevant to an area of resource processing/material science/recycling, not commercial promotions.

- Abstract shall be no more than 100 words, and 5 keywords (at least) are necessary.
- > The length of papers shall be within 3 printed pages.

2.8 Others

- > Foreword, reports of conferences and symposiums and information board, *etc.*
- > The length of papers shall be within 2 printed pages.

3. Submission Procedure

There are 2 options to submit a manuscript. Online submission will be accepted, dated and sent to the Editor-in-Chief of RPSJ from the secretary of editorial board. Postal submission is also processed as the same manner from RPSJ editorial office. Inappropriate papers for RESOURCES PROCESSING will be returned to the author.

3.1 Online submission

- Authors are able to submit manuscripts as Adobe PDF file after a registration. In order to complete this online submission, RPSJ requests authors to send an application form (website; http://www.nacos.com/rpsj/eng_index1.html) with the manuscript.
